NEW GROSS RECEIPTS LICENSE RATES EFFECTIVE 1996

Following are the new rates, which were approved by the Board of Supervisors, effective January 1, 1996.

- Sec. 4.1 Contractors.....13¢ per \$100 Gross Receipts.
- Sec. 5.1 Financial - Real Estate and Professional Services.....50¢ per \$100 Gross Receipts.
- Sec. 6.1 Repair, Personal, Business and other Services.....31¢ per \$100 Gross Receipts.
- 6-10) For telephone companies, one half of one percent of the prior year's gross receipts, excluding the charges for long distance call.

*For Gross Receipts of \$50,000 and above calculate tax at rates listed above on total gross receipts.

*There is a minimum license application fee of \$10.00 on the above if gross receipts are under \$50,000.

- Sec. 7.91 Itinerant Merchants, Auto Graveyards and others.....\$200.00 - 30 days or \$500.00 annually
 - Peddlers.....\$50.00 annually
 - Door-to-Door.....\$20.00 annually
