EDA of Amherst County COVID-19 Small Business Grant Application

This application is for locally owned Amherst County small businesses ranging from 1-20 employees. All grants must be used for business rent, business mortgage, business utilities, and business insurances. All small businesses are encouraged to apply but priority will be given to those businesses mandated to close and/or have been significantly affected by the COVID -19 virus.

The EDA has \$25,000 to aid County small businesses. Each grant will be up to \$1,000. Applications will be accepted starting on May 11, 2020, and continue until the grant funds are depleted.

Eligibility Criteria:

- Located in Amherst County and have a storefront
- Must be up to date on local taxes
- Have a valid business license if required
- Businesses must have been established and operational within Amherst County before March 2019
- For-profit, independently-owned (non-national chain and/or nationally franchised locations) small businesses
- The EDA may also require additional information before finalizing its review for eligibility
